Trail: Individual (\$75) or Family (\$125)

* For users who only use trails. Does not include use of stalls or arenas.

Day Use: Individual (\$20) or Family (\$40)

* Unrestricted one day membership including day use of stalls and full use of arenas and facility.

Trainers: (Base+\$60)

* We ask trainers who use the facility to teach lessons or conduct group activities ensure that their students have paid the appropriate fees and that the trainers pay a \$60 fee in addition to their base fee (Example: individual full use (\$125) + trainer (\$60) = \$185)

Overnight Stall Fee:(\$20)

*Anyone who stables their horse overnight must pay the overnight stall fee.

I have read and agree to abide by the WCCEC Rules and Policies (A current, negative EIA for all horses must be provided and on file at the WCCEC Office).
